RE: 2017-2018 Student Health Insurance Renewal

We have once again successfully completed negotiations and have a signed contract for the upcoming academic year 2017-2018 with our current vendor, UnitedHealthcare StudentResources. Based on claims data of our institutions, we believe we were able to negotiate the best possible premiums.

This year most of the benefits will remain the same as the current academic year, with a few exceptions:

- The athletic (IC Sports) insurance rider for both SHIP and PGH plans will only offer coverage levels at \$10K, \$20K, \$40k and \$90K. Your institution will be required to offer the same coverage levels for both your domestic (SHIP) and international (PGH) students. The PGH website will include an enrollment option for your international athletes.
- Students must attend classes for the first 31 days after the date for which coverage is purchased to maintain eligibility. Students enrolled in online courses meet this requirement but home study and correspondence courses remain ineligible. All plan brochures will reflect this change.
- Domestic students in one of the mandatory coverage categories must have a deductible of \$3,250 or less and/or co-pay per individual, per year, in order to waive out using their own comparable, creditable coverage.
- An exciting addition to the plan this year is an online counseling platform, BetterHelp. *See attachment for more information.*

A representative from UHCSR will contact you regarding your enrollment periods, the IC Sport coverage option and any other options specific to your institution.
