Discussion of UWG Course Scheduling Proposal:

- Dylan's introduction: Issues identified by administration with how we schedule classes, proposed schedule is a proposed solution. It consists of a block schedule and policy guidance.
- Thoughts from our student members?
 - Student most students prefer two 75 minute classes- commuting issues, easier to come to campus two times a week than three. Prefer 11 am classes to 9 am classes due to sleep schedule
 - Student concerned about the demand on dining locations during the break time
 - Student Likes the block schedule and the free hour- activities during the day that can't be attended due to classes, but this would be an opportunity for activities
- Faculty/Staff/Administrator feedback?
 - Faculty this assumes all students are the same and this may not work for them, this won't work at all for Nursing, clinical experience would be impacted, faculty activities may be moved to Friday which won't work for nursing either
 - Faculty field placement hours would make it difficult for this schedule to work. Typically have three hours one day a week classes.
 - Faculty we need a survey of student preferences, but the schedule is confusing, so we can't ask them about it
 - Dylan we can make the concrete recommendation for a student survey, and we can survey about class schedule in general rather than the block schedule.
 - Dylan what are the reasons they've done this?

- Faculty perceived that problem was that courses were offered at the same time.
- Faculty use the cohort system so that is not a problem for them
- Faculty there was a scheduling workgroup- where did this come from?
- o Dylan-historically that would have come through this committee or others
- Faculty Was registrar involved in the workgroup, and what would she think?
- Faculty suggest that we offer to create the survey
- Faculty all faculty should be able to see block schedule and provide feedback
- Dylan another concrete step we can take is requesting faculty comment
- Faculty program offers 3 and 4 credit hour classes so this would be complicated. The 4 credit hour classes only have a few time options. Faculty will be in conflict over who gets the better times. Could we try this out of a semester or year and have an assessment of it, and make adjustments?
- Faculty this might be more of an issue for general ed than for major courses
- Faculty Like the 1000 level solution, but what about faculty that teach lower level and upper level courses?
