Writing Submission:

In a two to three-page double-spaced scholarly essay, discuss your short- and long-term academic and career goals once you obtain the doctorate of nursing education (EdD). What is your area of research interest for the Doctorate in Nursing Education (EdD), and how does this relate to the needs for the future of nursing education? Explain this topic of interest and the need for scholarly inquiry in this area. Include the literature that supports its relevance, particularly as it relates to the future of nursing education. Submit this scholarly essay in a Word document.

Turnitin:

To ensure academic integrity, the Tanner Health System School of Nursing (THS SON) vigorously affirms the importance of an Honor Code as defined by the THS SON Undergraduate and Graduate Student Handbook.
